1. <u>Introduction</u>

I enclose information and forms for this year's Annual General Meetings required to be held in parishes during November 2019.

You will find the following Diocesan Acts helpful in this process

- Parish Administration Act 1994
- Appointments Act 1994
- Synod Act 1997

PLEASE NOTE THAT ELECTION OF **SYNOD REPRESENTATIVES AND PARISH MEMBERS OF THE CLERGY APPOINTMENTS BOARD** ARE NOT REQUIRED THIS YEAR AS THESE ARE THREE YEAR APPOINTMENTS. THE NEXT ELECTION TO THESE POSITIONS WILL NOT BE REQUIRED UNTIL NOVEMBER 2018.

2. Annual General Meeting of a Parish

Under Section 42 of the Parish Administration Act 1994 the business of the Parish AGM is as follows, apart from the reporting requirements set out in that section:

- To determine the size of the Parish Council and to hold an election for the same.
- To determine the number of representatives from centres and to hold an election for the same. The number of representatives from each centre may vary (See Section 44(f)).
- Appointment of Auditors

The Parish Annual General Meeting should be held before any Annual Church Meetings within the parish.

Submission of nominations for elections

Your attention is drawn to Section 46 of the Parish Administration Act:

"(2) A nomination shall be delivered to the incumbent or the parish secretary not less than one week before the meeting and a copy or details shall be displayed on appropriate church notice boards as soon as practicable after receipt."

3. Annual General Meeting of a Church

Under Section 44 of the Parish Administration Act 1994 the business of a Church AGM is as follows, apart from the reporting requirements set out in that section:

- Elect two Churchwardens
- Incumbent appoints a Churchwarden
- Depending on the Parish AGM determination, the meeting proceeds to elect members for Parish Council from that Centre.
- The Incumbent appoints representatives from centres. The ratio is determined according to Section 44(f).

If the AGM determines only one representative from some centres, the person must be a Churchwarden and is appointed by the Incumbent (Section 44(f) (iv)).

Where there is more than one representative from a Centre then one of them must be a Churchwarden (except for the Principal Centre of the Parish where the three Churchwardens are to be members of the Parish Council).
